Key questions to consider when writing a SIP are:

- Which things must we do because they are necessary to raise standards and because they will have the biggest impact on outcomes for pupils?
- How are we going to do them?
- Which issues do we have in common with other providers in the locality and, therefore, what actions might be better undertaken collaboratively by, or within, partnerships?

The plan should:

- Have a small number of headline priorities, a clear rationale and success criteria
- Include a one-page summary backed by more detailed action plans available to those who need them
- Be written in clear, simple English

OVERVIEW OF SCHOOL IMPROVEMENT PLAN

PLEASE NOTE – FULL VERSION IN ATTACHMENT

Priority 1: to introduce a new assessment system that evaluates progress against objectives in the 2014 National Curriculum

Rationale: the new National Curriculum introduced in 2014 requires an assessment system based on 'End of Year Expectations' rather than levels.

Ofsted Key Issue: Teachers sometimes move onto new work too quickly, before pupils have fully grasped this.

Priority 2: to close the attainment gap in reading, writing and grammar

Rationale: to ensure all children are 'Secondary ready' at the end of KS2

Priority 3: to close the attainment gap in Maths

Rationale – Ofsted Key Issue: pupils' achievement in Maths at KSI is not as good as that in Reading or Writing

Priority 4: to continue to develop high standards of behaviour, both in lessons and at other times throughout the school day.

Rationale: demands of the Cornerstone curriculum for increased collaboration between children. Need to reduce numbers of fixed term exclusions.

Priority 5: to ensure that the Christian Ethos of our school is reflected in high quality teaching and learning in RE and in the involvement of children in acts of Collective Worship.

Rationale: to ensure standards in RE meet or exceed those in English. To ensure Collective Worship is of a high quality in this voluntary aided school

Priority 6: to close the gap in attainment between the lowest attaining 20% of the children and the class average

Rationale: the new National Curriculum requires mastery of end of year expectations. All children have an entitlement to equal access to the curriculum and to be 'secondary ready'

CREATING THE SCHOOL IMPROVEMENT PLAN

- The plan is written by the senior leadership team and includes these key areas
 - SENCO led by the SENCO
 - English led by the English coordinator
 - Maths led by the Maths coordinator

- Arts led by the Arts coordinator
- Science/technology led by the Science/technology coordinator
- Ethos led by the Ethos coordinator
- The school prefers to work as team in creating and implementing School Improvement Plans
- The governors role is that of 'critical friends' in the creating of the School Improvement Plan
- The Finance Committee provides a full breakdown of costs involved for 'budgets'.
 PLEASE NOTE some of these costs are included on the attachment, however 'hidden' for privacy reasons

IMPLEMENTING THE SCHOOL IMPROVEMENT PLAN

- The plan is costed and then given to the finance committee and the Teacher/learning committee
- The plan is evaluated by each team.

Further matters raised

Proposal was raised by attendee as to whether any attendees had other ideas/concerns that could be addressed by the School Improvement Plan

Question was raise as to the appointment of new Headteacher – concern as to the ongoing support for existing improvement plan and continuing successful running of school

- New Headteacher most likely to start Jan 2015. As Head Teachers can only resign at three given times a year, the 29.04.15 (the date of Mr Edgington's resignation) being the last day for resignation, the 1st of Jan is the first date we could expect a new Headteacher to start, if we are employing an existing Head Teacher. Should we employ and existing Deputy Head, they could potentially start after the October Half-term.
- Mr Jackson will be acting Headteacher, with an open ended contract.
- The governors were rated by Ofsted as 'exceptional' and therefore the school can feel assured by their ongoing involvement in the running of the school and appointment of a new Head Teacher.
- The next governors meeting will be given over to the matter of the Appointment of new Headteacher
- Part of the criteria for a Headteacher at a Church Aided school is that they are a practicing Christian.

The point was raised as to how we assess the quality of the teachers/leaders at the school and therefore ensure the ongoing quality of teaching/leaders

- The Head Teacher is assessed by an external assessment body. This is a
 privately run body that is a 'School Improvement Partner'. This involves

- A report is submitted to the governors for acceptance
- The Teachers are assessed by Headteacher and Deputy Head teacher (the TAs meet with the SENCO) by the following methods
 - Performance against an approved target
 - Pupil progress
 - Teaching/learning
 - Own CPD
 - Data submission
 - Lesson observation
 - Data and work scrutiny

The question was raised as to 'what is in the School Improvement Plan for children who don't fall into the lower 20% area' - how the improvement plan supports and raises standards and achievements amongst the average and more able pupils?

- The Governor John Proctor stated that it is part of the role of the governors to remind the Head Teacher to also support these pupils.
- 'Mastery' is stated to be the goal for this group of pupils
 Embedding knowledge in all children broadening for competent children and intervention for others.

• It was noted that a discussion followed expressing concern as to whether the 'closing the gap in attainment' approach can lead to a 'dumbing down', rather than overall raising of standards.
